# 2<sup>nd</sup> QUARTER ACCOMPLISHMENT REPORT

#### I. Introduction:

This report contains all the activities conducted by the SRU staff covering the period of April to June 2014.

Strong partnership and collaboration of SRU staff with the Four (4) Clusters ABSNET, LGU, SWD service providers, stakeholders, Civil Society Organizations and other partner agencies activities and mandates of SRU were successfully conducted and delivered this quarter.
