## RESOLUTION RECOMMENDING NEGOTIATED PROCUREMENT UNDER EMERGENCY CASES MODALITY

WHEREAS, the President of the Republic of the Philippines issued Proclamation No. 929 s. 2020 declaring a State of Calamity throughout the Philippines for a period of six (6) months, unless earlier lifted or extended as circumstances may warrant;

WHEREAS, under the said Proclamation, all government agencies and LGUs are enjoined to render full assistance to and cooperation with each other and mobilize the necessary resources to undertake critical, urgent, and appropriate disaster response aid and measures in a timely manner to crucial and eliminate the threat of COVID-19;

WHEREAS, Section 53 (b) of RA 9184 and Section 53.2 of its 2016 Revised IRR provide that Negotiated Procurement may be resorted to and by procuring in case of imminent danger to life and property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities, and other public utilities;

WHEREAS, with the current situation in Zamboanga City, demands for disaster goods and services also increases and there are only limited supply in the area;

NOW, THEREFORE, WE, the members of the Bids and Awards Committee (BAC) hereby:

1. Recommend Negotiated Procurement under Emergency Cases Modality for procurement of goods and services related to COVID-19 disaster response aid in compliance to the Proclamation No. 929 s. 2020.
