

MINUTES OF MEETING
Bid Opening (Google Meet & Physical Meeting)
July 24, 2020 (9:00 am - 11:30 am)

DSWD FO IX conducted its Opening of Bids last July 24, 2020 (Friday) for the following projects:

Project Title	ABC (in Php)
Construction of Water Tower in PCDP, HFW, RSCC and Upgrade of Water Tower in HE	3,005,951.81

To avoid crowded meeting and to properly observe social distancing, DSWD FO IX conducted this pre-bid conference using the Google Meet platform attended by the following:

- b. TWG for Finance, Procurement, and Construction
- c. Interested Bidders
- d. Observers (COA)

Opening of bids was conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion following these steps:

1. Opening of mother envelope after ensuring that it was properly labeled and sealed
2. Opening of Technical Components envelope
 - a. Original Copy - BAC Secretariat
 - b. First Copy - BAC Chairperson
 - c. Second Copy - BAC Members
 - d. Third Copy - TWG

3. Opening of Financial Components envelope if declared PASSED for Technical Components

** If there are two bidders or more, all Technical Components envelopes were opened first (for all bidders) before opening the Financial Components envelope.*

4. Declaring the lowest bidder as opened subject for further bid evaluation by BAC and TWG.
