

THIS AGREEMENT, made this \_\_\_\_\_day of September, 2020 between DSWD Field Office IX, General Vicente Alvarez Street, Zamboanga City (hereinafter called the "Entity") and SSR Construction and Enterprises, Dacon Street, Suterville, San Jose Gusu, Zamboanga City, (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Upgrading of Resident's Quarter*, *Phase II in Home for the Elderly, Zamboanga City*, (hereinafter called "the Works") and the Entity has accepted the Bid for *Two Million Six Hundred Thousand Five Hundred Eighteen Pesos & 71/100 & 55/100* (Php2,600,518.71) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Notice of Award of Contract and the Bidder's conforme thereto;
  - (1) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
