THIS AGREEMENT, made this 14th day of *September*, 2020 between **DSWD Field Office IX**, General Vicente Alvarez Street, Zamboanga City (hereinafter called the "Entity") and **NAB Construction & Enterprises**, No. 9 Daisy Road Land Compound, Enriquez Drive, Sta. Catalina, Zamboanga City, (hereinafter called the "Contractor").

 - (l) Other contract documents that may be required by existing laws and/or the Entity.


