






Contract

THIS AGREEMENT, made this 7th day of September, 2020 between **DSWD Field Office IX**, General Vicente Alvarez Street, Zamboanga City (hereinafter called the "Entity") and **Shieham Construction and Enterprises**, 3rd Floor, JLC Building, Don Alfaro Street, Zamboanga City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Upgrading of Electrical System in DSWD Compound*, Mampang, Zamboanga City, (hereinafter called "the Works") and the Entity has accepted the Bid for *Twenty Four Million Four Hundred Eleven Thousand Eight Hundred Seventy Three Pesos & 76/100* (Php24,411,873.76) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
