



## Contract

THIS AGREEMENT, made this OCT 05 2020 day of September, 2020 between **DSWD Field Office IX**, General Vicente Alvarez Street, Zamboanga City (hereinafter called the "Entity") and **St. Joseph Construction Trading**, Sanito, Ipil, Zamboanga Sibugay, (hereinafter called the "Contractor").
