I hereby certify that DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE IX has not successfully undertaken Early Procurement Activities for at least (50%) of the value of eligible Procurement Projects based on the agency's Indicative Annual Procurement Plan/s consistent with the National Expenditure Plan for Fiscal Year 2021 in the following amounts:

Likewise, we would to cite some of the reasons why the Field Office IX failed to reach the 50% requirement, as this could be attributed, in part, to our failure to prepare for early procurement of Supplemental Feeding Program (SFP) for 2021 amounting to Php198,979,212.00. Due to the COVID-19 pandemic, the SFP guideline was revised to suit the implementation since there were no children at any Daycare Center/ Feeding Cites (following the AITF and DOH Guidelines). In effect, the 2020 SFP barely started with this circumstance.

Another reason is the drastic decrease of more than 50% as to our number of clients in various Centers, especially the Area Vocational Rehabilitation Center (AVRC) III--the trainings for the persons with disability (PWDs) were affected since there were no face to face classes, among others. Such activities were only allowed on late 2020.

This Certification is being made in compliance with the General Administration and Support Services Target of the Guidelines on the Grant of the Performance-Based Bonus for the Fiscal Year 2020, of the Administrative Order No. 25 Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring, Information, and Reporting Systems Memorandum Circular No. 2020-1. pursuant to the Implementation of EPA issued under Government Procurement Policy Board Circular No. 06-2019.
