THIS AGREEMENT made this day of December 2020 between DSWD Field Office IX, Gen. Vicente Alvarez Street, Zamboanga City, Philippines (hereinafter called "the Entity") of the one part and Lucky 8 Marketing (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., Procurement of COMMERCIAL RICE for the Supplemental Feeding Program (SFP) 10th Cycle Program Implementation in Zamboanga Sibugay - District 1 areas and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two Million Four Hundred Ninety Two Thousand Four Hundred Ninety Pesos & 00/100 (Php2,492,490.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (c) the Technical Specifications:
 - (d) the General Conditions of Contract;
 - the Special Conditions of Contract; (e)
 - the Performance Security; and (f)
 - the Entity's Notice of Award. (g)

- In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
- The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods 4. and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
