THIS AGREEMENT made this 18th day of December, 2020 between DSWD Field Office IX, Gen. Vicente Alvarez Street, Zamboanga City, Philippines (hereinafter called "the Entity") of the one part and D' Beam General Merchandise Corporation (hereinafter called "the Supplier") of the other

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz.  - the Performance Security; and (f)
 - the Entity's Notice of Award. (g)
- In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
