Contract Agreement Form

THIS AGREEMENT made this Aday of December 2020 between DSWD Field Office IX, Gen. Vicente Alvarez Street, Zamboanga City, Philippines (hereinafter called "the Entity") of the one part and HLYC Trading (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., Procurement WHOLE DRESSED CHICKEN for the Supplemental Feeding Program (SFP) 10th Cycle Program Implementation in Zamboanga del Norte - District 2 areas, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Three Million Eight Hundred Sixty Seven Thousand Two Hundred Forty Pesos & 00/100wo Million Eight Hundred Sixty Two Thousand Nine Hundred Ten Pesos & 00/100 (Php3,867,240.00 (hereinafter called "the Contract Price").

- The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
