CONTRACT AGREEMENT

THIS AGREEMENT made this 1st day of January, 2021 between DSWD Field Office IX, Zamboanga City, of the Philippines (hereinatter called "the Entity") of the one part and ALOHA SECURITY AND INVESTIGATION AGENCY CO., Zamboanga City, Philippines, (hereinafter called "the Supplier") of the other part;
