**RESOLUTION RECOMMENDING NEGOTIATED PROCUREMENT  
UNDER EMERGENCY CASES MODALITY**

**WHEREAS**, Proclamation No. 992, s.2020, declared the **State of Public Health Emergency** throughout the Philippines due to Covid-19.

**WHEREAS**, Republic Act No. 11469 or the "Bayanihan to Heal as One Act" was enacted declaring a **state of national emergency** over the entire country to control the spread of the disease.

**WHEREAS**, Section 53 (b) of RA 9184 and Section 53.2 of its 2016 Revised IRR provide that Negotiated Procurement may be resorted to and by procuring in case of imminent danger to life and property during a state of calamity, or **when time is of the essence** arising from natural or man-made calamities or **other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities, and other public utilities;**

**WHEREAS**, GPPB Resolution No 03-2020 approved the adoption of efficient, effective and expedient procurement procedures during a state of public health emergency. Among others, the Procurement Projects that may be covered by Negotiated Procurement is *"the lease of real property or venue for use as quarantine centers, evacuation sites, medical relief and aid distribution locations, warehousing facilities, or similar temporary disaster or emergency response facility as among those that may be procured under Negotiated Procurement (Emergency Cases);"*

**WHEREAS**, as part of the immediate response to protect health and safety, and for temporary shelter of the returning indigenous people/bajaus while waiting for their RT-PCR test result for COVID-19 and the conduct of investigation before sending them to their respective places of origin, there is a need for the immediate procurement of venue to accommodate the following returning bajaus that are scheduled to arrive on June 09, 2021 with estimated time of 8:00 to 11:00 in the evening.

**NOW, THEREFORE, WE**, the members of the Bids and Awards Committee (BAC) hereby:

1. Recommend Negotiated Procurement under Emergency Cases Modality for procurement of *temporary shelter of the indigenous people/bajaus (TIP) while waiting for their rt-pcr and the conduct of investigation;*
