**RESOLUTION RECOMMENDING NEGOTIATED PROCUREMENT
UNDER EMERGENCY CASES MODALITY**

WHEREAS, Proclamation No. 992, s.2020, declared the **State of Public Health Emergency** throughout the Philippines due to Covid-19.

WHEREAS, Republic Act No. 11469 or the "Bayanihan to Heal as One Act" was enacted declaring a **state of national emergency** over the entire country to control the spread of the disease.

WHEREAS, Section 53 (b) of RA 9184 and Section 53.2 of its 2016 Revised IRR provide that Negotiated Procurement may be resorted to and by procuring in case of imminent danger to life and property during a state of calamity, or **when time is of the essence** arising from natural or man-made calamities or **other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities, and other public utilities;**

WHEREAS, GPPB Resolution No 03-2020 approved the adoption of efficient, effective and expedient procurement procedures during a state of public health emergency. Among others, the Procurement Projects that may be covered by Negotiated Procurement is "*the lease of real property or venue for use as quarantine centers, evacuation sites, medical relief and aid distribution locations, warehousing facilities, or similar temporary disaster or emergency response facility as among those that may be procured under Negotiated Procurement (Emergency Cases);*"

WHEREAS, one of the children at *Regional Rehabilitation Center for Youth (RRCY)* was tested positive before he/she was returned to his/her families. And it was observed that some of the minors manifest some symptoms already, such as fever and cough;

WHEREAS, as part of the immediate response to protect the health and safety of all our clients and employees, there is an **urgent need to procure RT-PCR (Saliva) Test for 49 minors and RT-PCR (Swab) Test for 42 staff**, so that we will be aware of their status, and take appropriate actions.

WHEREAS, there is a shortage of COVID-19 testing kits at Polanco, Zamboanga del Norte, and it is only the **Red Cross- Zamboanga del Norte Chapter** that can accommodate the above number of clients;



NOW, THEREFORE, WE, the members of the Bids and Awards Committee (BAC) hereby:

1. Recommend Negotiated Procurement under Emergency Cases Modality for the procurement of **RT-PCR (Saliva) Test for 49 minors and RT-PCR (Swab) Test for 42 staff** of RRCY;
2. Further recommend the award of contract to **Red Cross- Zamboanga del Norte Chapter** to conduct the necessary RT-PCR Tests, which also passed the technical, legal, and financial capability requirements last June 18, 2021.
