CONTRACT AGREEMENT

THIS AGREEMENT made this 3/4 day of October 2021 between Department of Social Welfare and Development (DSWD) Field Office No. 9, Gen.  - Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of One Million One Hundred Eighty-Four Thousand One Hundred Pesos (Php1,184,100.00) or such other sums as may be ascertained, BJMARK MARKETING AND IRON WORKS agrees to supply and delivery the above-cited items in accordance with his/her/its Bid.
- The Department of Social Welfare and Development (DSWD) Field Office IX, Gen. Vicente Alvarez Street, Zamboanga City, Philippines, agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
