





# WOMEN-FRIENDLY SPACE (WFS)

WFS is a facility/structure established in evacuation camps, transitional sites or communities to address the practical and strategic needs of women during crisis situation, especially natural or man-made disasters. It aims to respond to the effects of displacement and vulnerability of women to crisis situations through the provision of wide range of services to help them cope with their situation and prepare them for their return to communities.

## OBJECTIVES

- Provide safe and accessible space for internally displaced women
- Increase awareness among women and community members on issues related to well-being, women's rights, sexual and reproductive health (SRH) and gender-based violence (GBV)
- Ensure access of internally displaced women to economic activities and other services
- Enhance knowledge and skills of internally displaced women to enable them to participate and have control on matters concerning their needs and interest

## COMPONENTS

### Gender Awareness Education and Information Sessions

WFS facilitators disseminate information about WFS and its services, as well as raise awareness of women on the prevention of gender-based violence

### Service Delivery

Access to services such as psychosocial support, reproductive health, cash for work, life skills using the Gender and Equality and Women Empowerment Framework

### Partnership and Networking

Tapping and maximizing local, national and international resources for the implementation of the services in WFS

## COVERAGE

### Immediately after disaster.

Internally-displaced women and children, especially pregnant and lactating women, women with disabilities, household heads, and young women in evacuation camps, transitional sites and disaster-affected communities

### During early recovery.

WFS may be used for gender awareness and education on women's empowerment and gender equality targeting men and boys





# STRATEGIC HELPDESKS FOR INFORMATION, EDUCATION, LIVELIHOOD & OTHER DEVELOPMENTAL INTERVENTIONS (SHIELD) AGAINST CHILD LABOR

SHIELD against Child Labor aims to withdraw children from the worst forms of child labor through the provision of holistic and immediate interventions at the community level. This project was developed to comply with RA 9231, and contribute to the removal of one (1) million children from child labor by 2025 as committed in the Sustainable Development Goals (SDGs) and National Program against Child Labor (NPACL).

## OBJECTIVES

- Identify child laborers in the community and ensure evidence-based case management through an operational Child Labor Local Registry (CLLR) System
- Improve access of child laborers and their families to appropriate services
- Increase awareness and capacities of child laborers, their families and duty-bearers in addressing child labor

## COMPONENTS

### Child Labor Local Registry (CLLR)



A database system which identifies who and where the child laborers are, as basis for planning, monitoring and prioritizing cases for appropriate interventions

### Barangay Helpdesk on Child Labor



Convergence of support services for child laborers and their families, through the barangay helpdesks to ensure immediate and accessible interventions at the community level

### Organizing, Advocacy, and Capability Building



Capacity building, organizing and advocacy activities among child laborers, their families, employers (e.g. *hacienderos*, contractors, financiers) and service providers to raise their awareness on the issues, laws, hazards of child labor and proper case management of child laborers

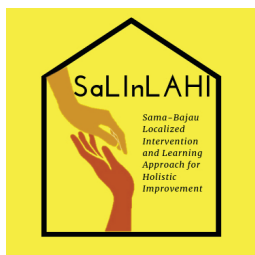

# SAMA-BAJAU LOCALIZED INTERVENTION and LEARNING APPROACH FOR HOLISTIC IMPROVEMENT (SaLInLAHI)

SaLInLAHI is a community-based project that is anchored on rights-based, child protection and culture-based approaches. It is focused on the learning and development of 0-4 year old Sama-Bajau children. The project aims to ensure and sustain the protection and promotion of the rights and well-being of poor Sama-Bajau children through culture-based early childhood care and development (ECCD) services.

## OBJECTIVES

- Provide age-appropriate and culture-based learning sessions for Sama-Bajau children aged 3-4 and prepare them for regular education
- Strengthen paternal, maternal and child care education to prevent maternal and child mortality among Sama-Bajau
- Strengthen the support of families and indigenous leaders for the protection of children 0-4 years old

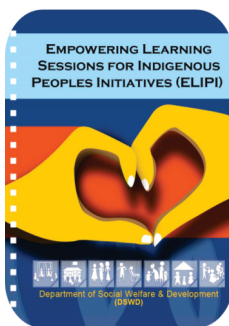
## COMPONENTS

### Culture-based Early Childhood Care and Development (ECCD) Sessions



Sessions grounded on indigenous knowledge, systems and practices of Sama-Bajau which are appropriate and adaptable to the growth and formation of children 0-4 years old

### Empowering Learning Sessions for the Indigenous Peoples Initiatives (ELIPI)

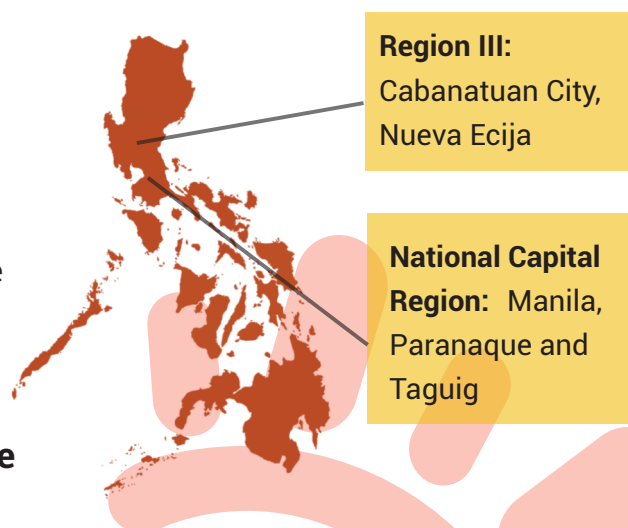


Sessions intended for parents of the Sama-Bajau students enrolled in the ECCD sessions to promote active participation in the community development process and preservation of cultural heritage

### Organization of Sama-Bajau Volunteers

Organizing and mobilization of Sama-Bajaus through the ELIPI towards becoming partners in advocacy campaign and project implementation

# STRATEGIES TOWARD ACCEPTANCE, REINTEGRATION & TRANSFORMATION (START) FOR RECOVERING DRUG DEPENDENTS AND THEIR FAMILIES

START is a community-based aftercare intervention for recovering drug dependents (RDDs) that have completed primary residential or outpatient rehabilitation programs in both government and non-government facilities. The project was developed in compliance to RA 9165 which requires the rehabilitated drug dependent to undergo after-care and follow-up treatment. It primarily aims to contribute to the effective reintegration and transformation of recovering drug dependents as self-reliant and socially responsible members of the society.

## OBJECTIVES

- Ensure bio-psychosocial, economic, moral and spiritual development of recovering drug dependents
- Organize and mobilize families and community members along support for discharged RDDs as well as individuals and families-at-risk
- Promote inter-agency partnership for resource augmentation, local policies and coordination of efforts

## COMPONENTS

### Service Delivery

Provision of services such as psychosocial interventions, financial assistance, capability building, skills training, and referral services to RDDs and their families

### Advocacy

Raising the awareness of the people in the community on the ill-effects of drug abuse and in removing social stigma on RDDs

### Organization of Support Groups

Formation and training of peer, family and community members to ensure successful reintegration of RDDs

### Establishment of Inter-Agency Mechanism

Identification and organization of different government, non-government agencies, academe and faith-based organizations with existing programs and services for RDDs and their families

# FAMILY DRUG ABUSE PREVENTION PROGRAM (FDAPP)

FDAPP is a community-based prevention program designed to educate families and communities on the adverse effects of drug abuse. The program adheres to the provisions of RA 9165 or the Dangerous Drugs Act of 2002 which recognizes the vital role of the family in educating its members on the ill effects of dangerous drugs.

## OBJECTIVES

- Create awareness of families and communities on the underlying causes of drug abuse and its ill effects
- Promote family life enrichment, strengthen Filipino family values and enhance relationships among its members
- Mobilize families in the promotion of effective parenting and drug-free home and community

## COMPONENTS

### Organization of Family Councils

Families are organized into family councils to identify needs, discuss possible solutions, provide socio-emotional support in times of struggles and challenges, and advocate on drug abuse prevention in the community

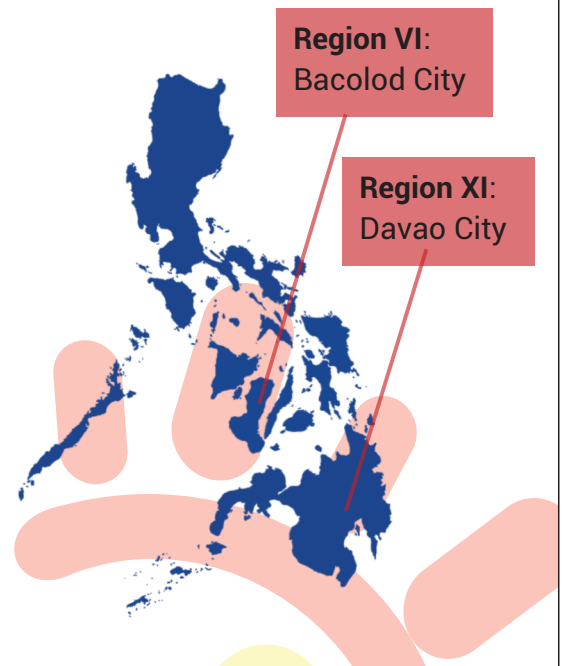
### Capacity Building

Training of families and service providers on health, socio-cultural, psychological, legal and economic dimensions and implications of the drug problem

### Advocacy, Networking and Mobilization

Local Anti-Drug Abuse Councils provide referral services and conduct information and education activities to promote drug-free homes and communities

## TARGET BENEFICIARIES

Families vulnerable to and potentially at-risk of drug use and abuse, including those:

- Residing in barangays, *sitios* or *puroks* with high incidence of drug abuse
- With members involved or has history of drug abuse
- With members who feel inadequate in their respective family roles and need help to function e.g. first time parents, solo parents
- With members who are not meeting their needs or discontented in current situations
- Experiencing stressful life situations at home, schools and communities
- Means of livelihood demand graveyard shift or longer working hours



# GENDER RESPONSIVE CASE MANAGEMENT (GRCM)

GRCM is a case management model for victim-survivors utilizing gender-, strengths- and rights-based perspectives, guiding principles, and tools to facilitate the healing and recovery of every survivor of gender-based violence (GBV). It starts from the recognition of gender biases against women and girls in the home, community and society, and pursues empowerment of women to see their value and status in relation to self, family and society. It also addresses the victim-survivor's immediate and long-term needs through a responsive helping relationship between the case manager and the survivor.

## OBJECTIVES

- Ensure the healing and recovery of victim-survivors of GBV through improved case management
- Facilitate and advocate timely, coordinated, age- and gender-appropriate delivery of services to meet the various needs of the sector
- Capacitate case managers on gender-sensitivity, self-awareness and reflective practices

## GRCM TOOLS

### Gender Violence Survivor Assessment (GVSA)

Uses a simplified listing of internal and external factors that are relevant to the presenting problems of the survivor

### Interdisciplinary Gender Assessment (IDGA)

Contains the assessment of the survivor by the interdisciplinary team towards the common goal of helping the survivor

### Domestic Violence Survivor Assessment (DVSA)

Using the context of the Change Model, this evaluates issues in two areas: the relationship and the survivor

## TARGET USERS

## GRCM PERSPECTIVES



### Rights-Based

Women, like men, have inherent, interrelated, indivisible and inalienable human rights, including a life free from violence

### Strengths-Based

Recognition of women's talents, abilities and competencies to exercise rights, empower selves, resist violence and recover from trauma

### Gender-Based

Understanding how difference between sexes affects and is affected by policies & programs, how it creates discrimination based on sex and how it imposes obstacles to person's opportunities and self-development





# TEAM BALIKATAN RESCUE IN EMERGENCIES (TeamBRE)

The TeamBRE project organizes and mobilizes fisherfolks for joint undertakings in rescue and evacuation of affected families in coastal barangays and disaster-prone communities. The project aims to enable the fisherfolks to become contributing members of their families and communities by making them partners in disaster preparedness and response while providing them alternative source of livelihood during lean or typhoon months. This is in response to the situational analysis which found that they have low economic productivity and have high casualty rates during typhoon.

## OBJECTIVES

- Enhance the skills of fisherfolks on disaster preparedness and response
- Organize the fisherfolks as TeamBRE volunteers to respond safely in disasters and emergencies in partnership with City/Municipal/Barangay Disaster Risk Reduction Management Council
- Augment family income during lean or typhoon months

## COMPONENTS

### Capability Building

Training of TeamBRE volunteers and project partners on Family Based Disaster Preparedness and Community Action for Disaster Response (CADRE)

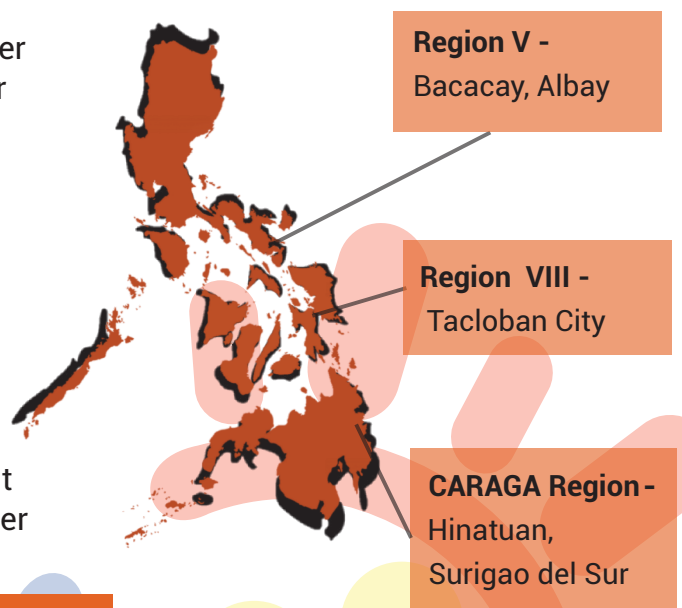
### Support Services

Provision of cash/ food for work, skills training, livelihood assistance and educational support to TeamBRE volunteers and their families

### Community Mobilization

Organization of trained volunteers, mapping of resources and establishment of linkages with partners towards disaster preparedness and response

# COMPREHENSIVE INTERVENTION AGAINST GENDER-BASED VIOLENCE (CIAGV)

CIAGV provides a holistic framework on prevention, response and reintegration to better understand and address gender-based violence (GBV) in the community. It envisions women, men, girls and boys to have reduced vulnerabilities to GBV through increased access to quality response and reintegration services and participation in preventive actions.

## OBJECTIVES

- Reduce incidence of gender-based violence, in both normal and emergency/crisis situations
- Improve provision of services to victim-survivors of GBV
- Facilitate socio-economic integration of GBV survivors

## COMPONENTS

### Prevention



Increase awareness of the general population and vulnerable groups (rural, urban, IP) on the knowledge and perception of GBV, and strategies to combat it

### Response



Improvement of service delivery systems to survivors through specialized trainings, improvement of centers and establishment of women-friendly centers during crisis situations

### Reintegration



Provision of services that will support the healing, rebuilding of lives and smooth return of victim-survivors to the community

# COMMUNITY ACTION AND RESOURCES FOR ACCESSIBLE AND BETTER LIVING ENVIRONMENT FOR PERSONS WITH DISABILITY

CARe-ABLE is a community-based intervention which enables persons with disability (PWDs) to access available resources, programs and services in the community. The project aims to provide holistic interventions to PWDs and reduce barriers for greater access to resources both from the government and non-government sectors.

## OBJECTIVES

- Increase access of PWDs to social protection programs
- Strengthen the city, municipal and barangay mechanisms in providing programs and services for PWDs.
- Improve capacities of PWDs for self-care and economic productivity
- Capacitate caregivers and communities towards appropriate care and support

## COMPONENTS

### Establishment of Barangay Helpdesks

A venue within the community for coordination with LGUs and other offices for faster, better and more coordinated delivery of services

### Support Services

Accessing PWDs and their families to health, nutrition and medical care, psychosocial services including assessment fees, mainstream education, livelihood, socio-cultural and social enhancement programs, among others

### Capability Building

Values enrichment, capability building and skills training to develop self-esteem, improve life perspectives and address personal barriers

### Strengthening Local Mechanisms

Establishment of linkages to public institutions, transport and business sectors, other government and non-government institutions to provide caring environment and support to PWDs

### Organization of Community Volunteers

Organizing and capacitating caregivers and other volunteers in providing proper care to their PWD family member

# HOME CARE SUPPORT SERVICES FOR SENIOR CITIZENS (HCSSSC)

HCSSSC is a community-based program that aims to provide quality care for the sick, frail, bedridden senior citizens in their own homes through their family/kinship carers and homecare volunteers. The project ensures that older persons, their families and communities promote healthy and harmonious family relationships and take effective steps to provide care and protection to the sick, frail, bedridden, disabled, abandoned and neglected senior citizens.

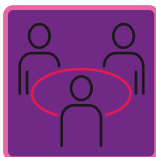
## OBJECTIVES

- Provide a package of caregiving services for senior citizens who have difficulty in performing activities of daily living due to old age and ailments
- Capacitate volunteers to plan and deliver home care support services to the senior citizens in their own homes
- Encourage active participation of the family in establishing and sustaining programs and services for the senior citizens
- Enhance capabilities of implementing LGUs/POs, senior citizens organizations in the delivery of services to home care beneficiaries
- Raise public awareness on the needs and aspirations of the senior citizens

### Social Mobilization

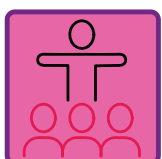
Home care volunteers are mobilized to serve as social support and companion in recreational and socialization activities

### Capability Building

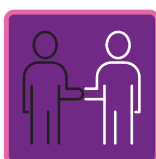
Conduct of skills enhancement on the care and management of senior citizens,

### Service Delivery

Based on the helping plan, beneficiaries are provided with home care, respite



services, physical fitness program, kinship care, palliative care and spiritual services

## REPORTING SYSTEM AND PREVENTION PROGRAM FOR ELDER ABUSE CASES

ReSPPEC is a community-based project which strengthens partnership between and among the senior citizens and stakeholders to prevent and respond to elderly abuse cases. The project primarily aims to protect the rights of the elderly against all forms of abuse by having the knowledge in detecting elder abuse and ways of preventing it, and the establishment of local reporting mechanisms and referral system in order to provide services for their full rehabilitation/recovery.

### SPECIFIC OBJECTIVES

- Establish local reporting mechanisms in management of elder abuse cases.
- Promote community awareness on the support and protection of the rights of elderly.
- Improve capacity of duty bearers on legal protection and assistance to elder abuse victims.
- Provide immediate care and protection to victims of elder abuse.
- Prevent re-occurrence of abuse by family members and caregivers.

### COMPONENTS



#### Reporting Mechanism and Databank

Systems, mechanisms and necessary procedures and protocols to formally report, investigate, intervene, document, monitor and provide follow-up services to victims of elder abuse in the community.



#### Advocacy

Raising family and community awareness on the information and services for both the victims and perpetrators of elder abuse.



#### Organization of support groups

Mobilizing families and peers towards providing safe and protective environment for the elderly.



#### Capacity Building

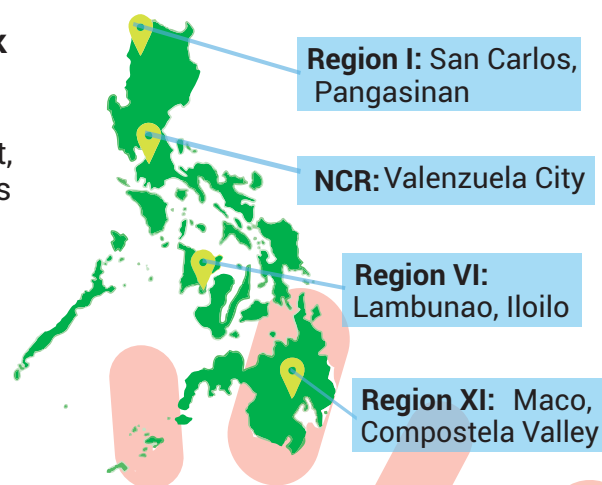
Provision of capability building to the program implementers in detecting, reporting, and managing elder abuse cases.



#### Case Management and Support Services

Establishment of helpdesk per barangay to facilitate timely case management and ensure immediate access to programs and services.

# BUKLOD PAGLAOM PARA SA CICT: HOLISTIC PSYCHOSOCIAL AND ECONOMIC (HOPE) INTERVENTIONS FOR CHILDREN IN CONFLICT WITH THE LAW

Buklod Paglaom para sa CICT is a project combining services interventions in center- and community-based settings. Using a holistic approach, it aims to reduce cases of re-offending by addressing the risk factors in CICT, their families and communities. It is based on the principles of restorative justice which gives emphasis on the rehabilitation and reintegration of CICT rather than retribution. The project adheres to the provision of RA 10630 which mandates LGUs to establish intensive juvenile intervention and support center within the Bahay Pag-Asa.

## OBJECTIVES



Enable CICT highly at risk of re-offending to develop and maintain positive and acceptable behavior

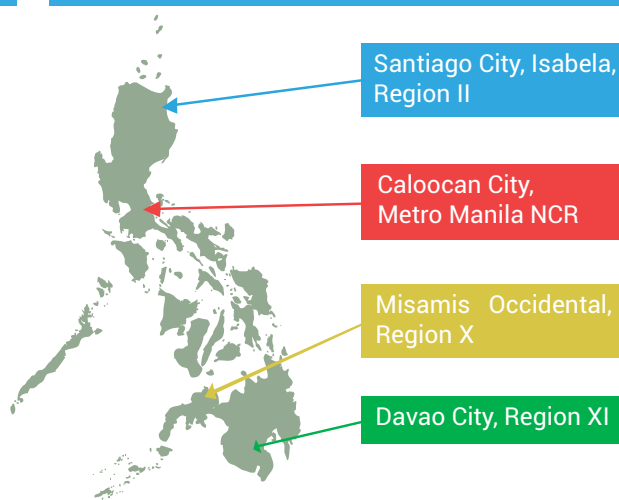


Help families become responsive to the needs of their children for support and protection

## PROJECT COMPONENTS



### Intensive After Care

Continuity of care to CICT who have completed their rehabilitation program which includes skills training, home visits, BCPC coaching, transitional living strategy and livelihood package

### Group Work and Advocacy Sessions

Responds to the problem about negative influence and pressures exerted on a child by peers to participate in gangs, engage in drug use or abuse and other illegal activities

### Individual and Family Sessions

Individual sessions address child's harmful behavior due to lack of ability to control aggression and distorted understanding of right and wrong. Family sessions focus on the dynamics of family relations to provide support and appropriate guidance to CICT

Above 12 years old to 15 years old, alleged to have committed serious crime with commitment order issued by the court

Above 12 years old to 15 years old, alleged to have committed an offense for the second time or oftener
