CONTRACT AGREEMENT

THIS AGREEMENT made this __tox ___ day of __knly ___ 2022 between Department of Social Welfare and Development (DSWD) Field Office No. 9, Gen. Vicente Alvarez Street, Zamboanga City, Philippines (hereinafter called "the Entity") of the one part and ANJENE INDUSTRIES INCORPORATION. Kendimaster Road, Maycauayan Bulacan, Philippines, (hereinafter called "the Supplier") of the other part;

 - iv. Supplemental or Bid Bulletins, if any

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- ii. Notarized Performance Securing Declaration or Performance Security
- iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of SEVEN HUNDRED TWENTY NINE THOUSAND EIGHT HUNDRED FIFTY ONLY (Php 729,850.00) or such other sums as may be ascertained, ANJENE INDUSTRIES INCORPORATION, agrees to supply and deliver the above-cited items in accordance with his/herits Bid.
- The Department of Social Welfare and Development (DSWD) Field Office IX. Gen. Vicente Alvarez Street, Zamboanga City, Philippines, agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
