WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Procurement of CY 2022 SFP 12TH CYCLE IMPLEMENTATION IN ZAMBOANGA SIBUGAY PROVINCE, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of SEVEN HUNDRED THIRTY-NINE THOUSAND NINE HUNDRED TWENTY GOUR PESOS ONLY (Php 739,924.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
- Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of SEVEN HUNDRED THIRTY-NINE THOUSAND NINE HUNDRED TWENTY-FOUR PESOS ONLY (739,924.00) or such other sums as may be ascertained, HLYC TRADING. agrees to supply and deliver the above-cited items in accordance with his/her/its Bid.
- The Department of Social Welfare and Development (DSWD) Field Office IX, Gen. Vicente Alvarez Street, Zamboanga City, Philippines, agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
