DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) AND RECOMMENDING AWARD OF CONTRACT TO D'BEAM MARKETING

WHEREAS, last March 15, 2022, the Department of Social Welfare and Development (DSWD) posted/published the Invitation to Bid for the Procurement of 3-in-1 Instant Coffee & Instant Choco Malt Drink for Stockpiling in the Warehouse to produce 20,000 Family Food Packs in Zamboanga Peninsula and 20,000 standby raw materials with an Approved Budget for the Contract (ABC) of Three Million Eighty Five Thousand Eight Hundred Pesos Only (Php 3,085,800.00);

WHEREAS, on the 5th of April, the scheduled opening of bids has begun with (7) seven potential bidders who had submitted their respective bid proposals, but only (3) four bidders who qualified for the "PASS/FAIL" criteria and declared D'BEAM MARKETING as the Lowest Bidder as opened;

WHEREAS, the BAC declared D'BEAM MARKETING as the Lowest Calculated Bidder (LCB) per BAC Resolution No. 041-04-2022 dated April 12, 2022 for the ITB-2022-03-008: Procurement of 3-in-1 Instant Coffee & Instant Choco Malt Drink for Stockpiling in the Warehouse to produce 20,000 Family Food Packs in Zamboanga Peninsula and 20,000 standby raw materials with a bid price of Two Million Six Hundred Twenty Seven Thousand One Hundred Pesos Only (Php 2,627,100.00):

WHEREAS, a corresponding post qualification was conducted by the Bids and Awards Committee and Technical Working Group (TWG) of the BAC on April 22, 2022;

WHEREAS, the TWG and BAC conducted meeting on April 23, 2022 and reported its validation and confirmation of the legal, technical and financial requirements submitted by D'BEAM MARKETING and found to be responsive;

NOW, THEREFORE, WE, the members of the Bids and Awards Committee (BAC) hereby:
