DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) AND RECOMMENDING AWARD OF CONTRACT TO HLYC TRADING

WHEREAS, last March 15, 2022, the Department of Social Welfare and Development (DSWD) posted/published the Invitation to Bid for the Procurement of Food Items for BANGUN Project for 180-days supplementary feeding of 2400 children and 800 PLW in Sulu Province for 2022 implementation with an Approved Budget for the Contract (ABC) of Sixteen Million One Hundred Twenty Five Thousand One Hundred Twenty Pesos Only (Php16,125,120.00);

WHEREAS, on the 5th of April, the scheduled opening of bids has begun with (3) three potential bidders who had submitted their respective bid proposals, but only (1) one bidder who qualified for the "PASS/FAIL" criteria and declared HLYC Trading as the Lowest Bidder as opened;

WHEREAS, the BAC declared HLYC Trading as the Lowest Calculated Bidder (LCB) per BAC Resolution No. 041-04-2022 dated April 12, 2022 for the ITB-2022-01-003: Procurement of Food Items for BANGUN Project for 180-days supplementary feeding of 2400 children and 800 PLW in Sulu Province for 2022 implementation a bid price of Fifteen Million Nine Hundred Sixty Two Thousand Seven Hundred Ninety Six Pesos Only (Php15,962,796.00);

WHEREAS, a corresponding post qualification was conducted by the Bids and Awards Committee and Technical Working Group (TWG) of the BAC on April 22, 2022;

WHEREAS, the TWG and BAC conducted meeting on April 23, 2022 and reported its validation and confirmation of the legal, technical and financial requirements submitted by HLYC Trading and found to be responsive;

NOW, THEREFORE, WE, the members of the Bids and Awards Committee (BAC) hereby:
