## BIDS AND AWARDS COMMITTEE Resolution No. <u>097-06-2022</u> June 10, 2022

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) AND RECOMMENDING AWARD OF CONTRACT TO D'BEAM GENERAL MERCHANDISE CORPORATION

WHEREAS, last May 03, 2022, the Department of Social Welfare and Development (DSWD) posted/published the Invitation to Bid for the Procurement CY 2022 Grocery Products for DSWD FO IX-RRCY, Dipolog, ZDN (1st Semester Expenses) with an Approved Budget for the Contract (ABC) of One Million Five hundred Eight thousand Four hundred Ten Pesos Only (Php 1,508,410.00);

WHEREAS, on the 5th of April, the scheduled opening of bids has begun with (3) three potential bidders who had submitted their respective bid proposals, but only (2) two bidders who qualified for the "PASS/FAIL" criteria and declared D'BEAM GENERAL MERCHANDISE CORPORATION as the Lowest Bidder as opened;

WHEREAS, the BAC declared D'BEAM GENERAL MERCHANDISE CORPORATION as the Lowest Calculated Bidder (LCB) per BAC Resolution No. 088-05-2022 dated May 26, 2022 for the ITB-2022-04-020: Procurement CY 2022 Grocery Products for DSWD FO IX-RRCY, Dipolog, ZDN (1st Semester Expenses) with a bid price of One Million Four Hundred Five Thousand Eight Hundred Ten Pesos Only (Php 1,405,810.00);

WHEREAS, a corresponding post qualification was conducted by the Bids and Awards Committee and Technical Working Group (TWG) of the BAC on June 2-3, 2022;

WHEREAS, the TWG and BAC conducted meeting on June 3, 2022 and reported its validation and confirmation of the legal, technical and financial requirements submitted by D'BEAM MARKETING and found to be responsive;

NOW, THEREFORE, WE, the members of the Bids and Awards Committee (BAC) hereby:

- 1. Declare D'BEAM as the Lowest Calculated and Responsive Bidder (LCRB); and
- 2. We further recommend Award of Contract to D'BEAM MARKETING for the IITB-2022-04-020 Procurement CY 2022 Grocery Products for DSWD FO IX-RRCY, Dipolog, ZDN (1st Semester Expenses) with a bid price of One Million Four Hundred Five Thousand Eight Hundred Ten Pesos Only (Php 1,405,810.00);
