CONTRACT AGREEMENT

THIS AGREEMENT made this 12 day of SEVIEMBEL 2022 between Department of Social Welfare and Development (DSWD) Field Office No. 9, Gen. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of ONE MILLION FOUR HUNDRED FIVE THOUSAND EIGHT HUNDRED TEN PESOS ONLY (Php 1,405,810.00) or such other sums as may be ascertained, D'BEAM GENERAL MERCHANDISE CORPORATION, agrees to supply and deliver the above-cited items in accordance with his/her/its Bo
