## BAC RESOLUTION DECLARING CANCELLATION OF BIDDING

WHEREAS, the Department of Social Welfare and Development - Field Office IX's Bids and Awards Committee (BAC) posted ITB-2022-11-056 Invitation to Bid for Procurement of CY 2022 Various Office and Other Supplies for PSD - CIU AICS Staff of DSWD FO IX, Zamboanga City with 112 listed items with an Approved Budget for the Contract amounting to P1,893,908.20, in the (1) DSWD Transparency Website, (2) PHILGEPS Website, (3) DSWD FO IX Facebook page, and (4) in conspicuous place;

WHEREAS, on November 15, 2022 the scheduled Pre-Bid Conference was conducted at the Conference Room of DSWD Field Office IX and streamed using the Google Meet platform (meet.google.com/tiq-rfvb-cez), wherein the BAC Members, TWGs and End User presented the Eligibility requirements and discussed each item of the technical specification of the said procurement;

WHEREAS, during the discussion of the technical specifications of the 112 listed items, it was found out that there were **duplicated items** with different unit prices and such variance or difference materially change the total ABC;

WHEREAS, Section 35.6 of the IRR of RA 9184 provides "Without prejudice to Sec. 35.1 hereof, the BAC is authorized, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities, for any justifiable reason, such as but not limited to:

- a) the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the end-user unit;
- *b) the project is no longer necessary as determined by the end-user unit;*
- c) the source of funds for the project has been withheld or reduced through no fault of the PE; or
- d) brought about by the declaration of a State of Calamity, or implementation of community quarantine or similar restrictions."

**NOW, THEREFORE,** We, the members of the Bids and Awards Committee hereby resolve as it is hereby RESOLVED:
