CONTRACT AGREEMENT

THIS AGREEMENT made this 24 day of 5ANDAY 2023 between Department of Social Welfare and Development (DSWD) Field Office No. 9, Gen. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- ii. Notarized Performance Securing Declaration or Performance Security
- iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum Five Hundred Thirty-Six Thousand Nine Hundred Fifty Pesos Only (Php 536,950.00) or such other sums as may be ascertained, BJMARK MARKETING & IRON WORKS. agrees to supply and deliver the abovecited items in accordance with his/her/its Bid.
