CONTRACT AGREEMENT

THIS AGREEMENT made this 28 day of APRIL 2023 between **Department of Social Welfare and Development (DSWD) Field Office No. 9**, Gen. Vicente Alvarez Street, Zamboanga City, Philippines (hereinafter called "the Entity") of the one part and **LUMAD SA ADGAWAN FARMERS MPC, La Paz Agusan Del Sur**, Philippines, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **ITB-2023-02-002 PROCUREMENT OF CY 2023 FOOD STUFF TO BE USED FOR 180 DAYS SUPPLEMENTARY FEEDING OF 2800 CHILDREN AND 300 PLW IN TAWI-TAWI PROVINCE FOR 2023 IMPLEMENTATION**, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SEVENTEEN MILLION SIX HUNDRED FORTY-ONE THOUSAND FIVE HUNDRED SEVENTY-FIVE PESOS & 48/100(Php 17,641,575.48)** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - ii. Notarized Performance Securing Declaration or Performance Security
 - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **SEVENTEEN MILLION SIX HUNDRED FORTY-ONE THOUSAND FIVE HUNDRED SEVENTY-FIVE PESOS & 48/100(Php 17,641,575.48)** or such other sums as may be ascertained, **LUMAD SA ADGAWAN FARMERS MPC**. Agrees to supply and deliver the above-cited items in accordance with his/her/its Bid.
4. The **Department of Social Welfare and Development (DSWD) Field Office IX**, Gen. Vicente Alvarez Street, Zamboanga City, Philippines, agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






