CONTRACT AGREEMENT

THIS AGREEMENT made this ____ day of _____ JUN _0 5 _2023 ____ 2023 between Department of Social Welfare and Development (DSWD) Field Office No. 9, Gen. Vicente Alvarez Street, Zamboanga City, Philippines (hereinafter called "the Entity") of the one part and WAFFLE TIME INC. QHP Bldg. Door 4, Arsenal Street, Iloilo City Philippines, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly ITB-2023-03-012 PROCUREMENT OF FOOD ITEM (CANNED CORN BEEF 150 GRAMS 48'S) FOR STOCKPILE IN THE WAREHOUSE OF DRMD OF THE DSWD FIELD OFFICE IX, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of FOURTEEN MILLION THREE HUNDRED SIXTY FOUR THOUSAND PESOS ONLY (Php 14,364,000.00) (hereinafter called "the Contract Price").

 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- ii. Notarized Performance Securing Declaration or Performance Security
- iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

 FOUR THOUSAND PESOS ONLY (Php 14,364,000.00) or such other sums
