

**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE  
BIDDER AND RECOMMENDING AWARD OF CONTRACT TO BJMARK MARKETING  
AND IRON WORK**

**WHEREAS**, the Department of Social Welfare and Development - Bids and Awards Committee (DSWD FO IX-BAC ) posted the Invitation to Bid in DSWD Transparency Website and posted the same in the PHILGEPS, in conspicuous place for the following Invitation to Bids:

1. **ITB-2023-06-046:** Procurement of CY 2023 Frozen Goods (2nd Semester) for the Consumption of DSWD FO IX Home for the Elderly Clients with an approved budget for the contract of Php 781,050.00;
2. **ITB-2023-06-047:** Procurement of CY 2023 Grocery Items (2nd Semester) for the Consumption of DSWD FO IX Home for the Elderly Clients with an approved budget for the contract of Php 1,539,880.00
3. **ITB-2023-06-048:** Procurement of CY 2023 Fruits & Vegetables (2nd Semester) for the Consumption of DSWD FO IX Home for the Elderly Clients with an approved budget for the contract of Php 635,398.00;
4. **ITB-2023-06-049:** Procurement of CY 2023 Seafood Stuff (2nd Semester) for the Consumption of DSWD FO IX Home for the Elderly Clients with an approved budget for the contract of Php 977,600.00.

**WHEREAS**, on **July 11, 2023 at 9:30 AM** the Bids and Awards Committee (BAC) held the pre-bid conference which was attended by various prospective bidders.

**WHEREAS**, during the Pre-Bid conference, the BAC Secretariat presented to prospective bidder all the mandatory requirements for Financial and Technical Components and soliciting questions and queries from bidders for clarification and understanding, while the end user also presented the technical specifications for the items to be procured;

**WHEREAS**, on **July 26, 2023, 9:30 am** the scheduled opening of bids was conducted at the Conference Room of DSWD Field Office IX and streamed using the Google Meet platform, there were only One (1) Bid proposal per procurement submitted to BAC from BJMark Marketing and Iron Works and subjected to Eligibility Screening before the BAC & TWG using the “pass/fail” criterion:

**WHEREAS**, the BAC convened on 9:30 AM of July 27, 2023 for **BID EVALUATION** at the DSWD Field Office IX Conference Room. During the bid evaluation the members of the BAC and its TWGs scrutinized and reviewed the technical and eligibility documents and checked the mathematical computation of financial components of **BJMark Marketing and Iron Works**, and the BAC found all documents to be in order (see Resolution No. 069-07-2023) and scheduled to conduct post-qualification;

**WHEREAS**, during **Post Qualification** stage last **August 4, 2023**, upon careful examination on the validity of financial and technical requirements (like mayor's permit, DTI, cert. of registration, ITRs & etc.), including the availability of similar items for the said procurements, **BJMark Marketing and Iron Works** is found to be responsive in all aspects.

**NOW, THEREFORE, WE**, the members of the Bids and Awards Committee (BAC) hereby resolved to:

- A. Declare **BJMark Marketing and Iron Works** as the **Lowest Calculated and Responsive Bidder (LCRB)** for the following procurements:


