CONTRACT AGREEMENT

THIS AGREEMENT made this ______ day of _______ 2023 between Department of Social Welfare and Development (DSWD) Field Office No. 9, Gen. Vicente Alvarez Street, Zamboanga City, Philippines (hereinafter called "the Entity") of the one part and 4AC CONSTRUCTION Block 1 Lot 5 Zampen Subdivision, Boalan, Zamboanga City Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly ITB-2023-05-017 Procurement of Services and Materials (Works) for the Upgrading of the Gate, Garage, and Guard House at Home for the Elderly of DSWD FO IX. And has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Five Hundred Ninety Thousand Four Hundred Sixty Four Pesos and 69/10 (Php 1,590,464.69) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - ii. Technical Specifications:
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- ii. Notarized Performance Securing Declaration or Performance Security
- iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of One Million Five Hundred Ninety Thousand Four Hundred Sixty Four Pesos and 69/10 (Php 1,590,464.69) or such other sums as may be ascertained4AC CONSTRUCTION Agrees to supply and deliver the above-cited items in accordance with his/her/its Bid.
- The Department of Social Welfare and Development (DSWD) Field Office IX, Gen. Vicente Alvarez Street, Zamboanga City, Philippines, agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
