CONTRACT AGREEMENT

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly of ITB-2023-06-036 SUPPLY AND DELIVERY OF COMMERCIAL RICE FOR DSWD FO IX SFP 13TH CYCLE IMPLEMENTATION IN ZSP DISTRICT II. And has accepted a Bid by the Supplier for the supply of those goods and services in the sum of FOUR MILLION EIGHT HUNDRED FORTY THREE THOUSAND ONE HUNDRED EIGHTY PESOS ONLY (Php 4,843,180.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- ii. Notarized Performance Securing Declaration or Performance Security
- iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
- Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of FOUR MILLION EIGHT HUNDRED FORTY
 THREE THOUSAND ONE HUNDRED EIGHTY PESOS ONLY (Php
 4,843,180.00) or such other sums as may be ascertained, D'BEAM GENERAL
 MERCHANDISE CORPORATION. Agrees to supply and deliver the above-cited
 items in accordance with his/her/its Bid.
- 4. The Department of Social Welfare and Development (DSWD) Field Office IX, Gen. Vicente Alvarez Street, Zamboanga City, Philippines, agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
