CONTRACT AGREEMENT

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly of ITB-2023-06-040 SUPPLY AND DELIVERY OF COMMERCIAL RICE FOR DSWD FO IX SFP 13TH CYCLE IMPLEMENTATION IN ZDS DISTRICT II. And has accepted a Bid by the Supplier for the supply of those goods and services in the sum of SIX MILLION SEVEN HUNDRED FIFTY THREE THOUSAND TWO HUNDRED FIFTY SEVEN PESOS AND 50/100 (Php 6,753,257.50) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
