

WHEREAS, the Department of Social Welfare and Development - Bids and Awards Committee (DSWD FO IX-BAC) posted the Invitation to Bid in DSWD Transparency Website & Facebook Page, and in conspicuous place of and posted the same in the PHILGEPS Website for the *ITB-2023-07-064: Procurement of Labor and Materials for the Construction of InfirmarY/Clinic at RRCY, Anastacio Polanco, Zamboanga del Norte* with an approved budget for the contract (ABC) of *Php 1,549,003.81*;

WHEREAS, on **9:30 AM, August 04, 2023**, the Bids and Awards Committee (BAC) held the Pre-Bid conference which was attended by various prospective bidders;

WHEREAS, during the PRE-BID conference, the BAC Secretariat presented to prospective bidder all the mandatory requirements for Financial and Technical Components and soliciting questions and queries from bidders for clarification and understanding, while the end user also presented the technical specifications for the items to be procured;

WHEREAS, on **9:30 AM of August 16, 2023** the scheduled BID OPENING was conducted at the Conference Room of DSWD Field Office IX and streamed using the Google Meet platform, There were Five (5) contractors who submitted their bid proposals within the timeline namely –*NRMM Const. & Devt. Corp., K-Lanz Const., MJMari Builders & Construction, RT Construction & Supplies and DCEE Construction*;

WHEREAS, during BID OPENING, after being screened, examined and assessed of both technical and financial components, only *NRMM Const. & Devt. Corp. and K-Lanz Construction* were found to be *responsive* as the BAC unanimously rated it “**PASSED**” for both technical and financial component requirements while the other three bidders rated “**FAILED**” in the 1st Envelope due Non-Compliance to the mandatory requirement prescribed by the GPPB, details are shown on table below:

WHEREAS, during the BID EVALUATION on 1:30 PM of August 22, 2023, the BAC scrutinized and reviewed the technical and eligibility documents and checked the mathematical computation of financial components of *NRMM Const. & Devt. Corp.* and *K-Lanz Construction* and found them to be in order, wherein *NRMM Const. & Devt. Corporation* declared as the Lowest Calculated Bids (LCB), thus the BAC scheduled to conduct **Post Qualification**;

WHEREAS, during POST-QUALIFICATION stage last **August 26, 2023**, upon careful examination on the validity of financial and technical requirements, to include actual validation of the declared SLCC, NRMM CONSTRUCTION AND DEVT. CORP. are found to be responsive in all aspects.





NOW, THEREFORE, We, the members of the Bids and Awards Committee hereby resolve as it is hereby **RESOLVED:**



- B. To Recommend Award of Contract to **NRMM CONSTRUCTION AND DEV'T. CORP.** for the above mentioned procurement.


