CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of _____ 2023 between Department of Social Welfare and Development (DSWD) Field Office No. 9, Gen. Vicente Alvarez Street, Zamboanga City, Philippines (hereinafter called "the Entity") of the one part and K-LANZ CONSTRUCTION AND SUPPLIES Safaya Building, Veterans Avenue, Zamboanga City Philippines, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly ITB 2023-08-069 Procurement of Services and Materials (works) for the Construction of Warehouse at RRCY of DSWD Field Office IX. And has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Six Million Sixty-Five Thousand Nine Hundred Twenty-Three Pesos and 24/100 (Php 6,065,923.24) (hereinafter called "the Contract Price").

 - iv. Supplemental or Bid Bulletins, if any

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- ii. Notarized Performance Securing Declaration or Performance Security
- iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Six Million Sixty-Five Thousand Nine Hundred
 Twenty-Three Pesos and 24/100 (Php 6,065,923.24) or such other sums as
 may be ascertained K-LANZ CONSTRUCTION AND SUPPLIES agrees to supply
