

**WHEREAS**, the Department of Social Welfare and Development - Bids and Awards Committee (DSWD FO IX-BAC ) posted the Invitation to Bid on DSWD Transparency Website & Facebook Page, and in a conspicuous place and posted the same in the PHILGEPS Website for the **EPAITB-2024-01-018**: Procurement of CY 2024 Food Stuff (Sea Foods) for the Clients of Home for the Elderly – DSWD FOIX – Centers and Institutions (EPA) with an approved budget for the contract (ABC) of Php 907,000.00;

**WHEREAS**, on **9:30 AM, November 22, 2023**, the Bids and Awards Committee (BAC) held the Pre-Bid conference which was attended by various prospective bidders;

**WHEREAS**, during the PRE-BID conference, the BAC Secretariat presented to prospective bidder all the mandatory requirements for Financial and Technical Components and soliciting questions and queries from bidders for clarification and understanding, while the end user also presented the technical specifications for the items to be procured;

**WHEREAS**, on **9:00 AM of December 5, 2023** the scheduled **BID OPENING** was conducted at the Conference Room of DSWD Field Office IX and streamed using the Google Meet platform <https://meet.google.com/ivw-bdsm-iqv> There are only Two (2) prospective bidders who submitted their respective bid proposal in a timely manner namely: **(1) Via Alto General Merchandise and (2) BJMark Marketing & Iron Works.;**

**WHEREAS**, during **BID OPENING**, after being screened, examined and assessed of both technical and financial components, it was declared that **Via Alto General Merchandise** were found to be *the Single/Lowest Bid as Opened*, detailed of ranking as stated below;

Furthermore, **Via Alto General Merchandise** were declared as Single/Lowest Calculated Bidder (LCB) and recommended to conduct post-qualification (per LCB BAC Resolution No. 2023- 12-128);

**WHEREAS**, the BAC, along with the Technical Working Group proceeded to conduct **Post Qualification** on **December 22, 2023**, upon careful examination on the validity of financial and technical requirements (like mayor's permit, DTI, cert. of registration, ITRs), including the availability of similar items for the said procurements, Hereby, declaring **Via Alto General Merchandise** to be **POST-QUALIFIED**.

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee hereby resolve as it is hereby **RESOLVED**:




