Sealed bids shall be submitted in a separate envelope for each lot accompanied by a bidder's bond in a form of cash, cashier's check or manager's check in the amount equivalent to at least ten percent (10%) of the total bid offered and shall submitted to RPDAC secretariat at Property and Supply Section (PSS) Office, Administrative Division, Ground Floor, DSWD FO IX Building, not later than **9:30** am of **September 25, 2024**.

Opening and deliberation of the bid shall be at 10:30 AM on the same date, via plenary. Bidders/Representatives can participate and witness the opening of bids at the above-mentioned venue.
